



2. Earnest money shall be paid in the form of Deposit at call in favour of Municipal Corporation, Bathinda, payable at Bathinda.
3. Processing fee will be only be accepted through Net Banking (Direct Debit) and IPG (Credit/Debit card).
4. All the payments (EMD and Tender form cost) can be made either online or by submitting original DAC in the office of Corporation Engineer, Municipal Corporation, Bathinda, 2nd floor, in a Envelope marked Earnest Money, Tender cost fee and other necessary documents for the work of \_\_\_\_\_ on or before 1.30 PM on 19/8/2014 failing which the tender will be rejected.
5. Bidders/Contractors/tenderes can access for tender documents on the website mentioned above, fill them and submit the complete tender document into Electronic Tender on the website. Bidders/Contractors shall attach scanned copies of all the paper, i.e. Earnest Money, Processing Fee, Tender cost fee and certificates as required in terms and conditions.

# **TERMS & CONDITIONS FOR DNIT (Not for Press)**

1.	Electronic tenders shall be opened in the office of the Corporation Engineer in the presence of Contractors or their authorized representatives (if they wish) on the date and time prescribed in the tender notice.
2.	If tender date happens to be a holiday, the tenders shall be received and opened on the next working day. Regarding this, no separate publication in Newspaper will be given but corrigendum/ modification/correction may be posted at the website.
3.	Sales Tax Number is must for supply items.
4.	Cost of the tender form is Rs. 200/- which is payable in the form of DD in favour of Municipal Corporation Bathinda, payable at Bathinda.
5.	Road Materials shall be stacked and measured at different areas, as per requirement and at different works.
6.	Free of Cost items, if quoted, shall be adjusted first or proportionally as desired by the Engineer Incharge.
7.	The work will be executed in accordance with the Punjab PWD MoRTH specifications/ agreement and the final payment will be made to the contractor on the basis of the overall lowest statement as worked out in the final stage, considering all the tenders received against the individual work/item.
8.	Sales Tax, Income Tax and other levies will be deducted from the contractor's bill as per rules.
9.	DNIT and MW-4 shall be the part of the agreement.
10.	(i) In case of any dispute or disagreement arising out of contract agreement Commissioner, Municipal Corporation, Bathinda shall be the Arbitrator, whose decision shall be final and binding upon both the parties. (ii) It shall be a essential term of this contract that in order to avoid frivolous claims, the party invoking arbitration shall specify the disputes based on facts and calculation stating the amount claimed under each claim and shall furnish a "deposit-at-call" for ten percent of the amount claimed, on a scheduled bank in the name of the arbitrator by his official designation who shall keep the amount in deposit till the announcement of the award. In the event of an award in favour of the claimant, the deposit shall be refunded to him in proportion to the amount awarded with respect to the amount claimed and the balance, if any, shall be forfeited and paid to the other party.
11.	Quoted tender should be as per approved class by the individual contractor otherwise it shall be invalid.
12.	Any or all tenders can be rejected by the competent Authority without assigning any reason.
13.	Substandard materials will be rejected and shall not be payable.
14.	Any defect found in quality/quantity shall be accountable towards the contractor during execution and up to a period of one year from the date of completion irrespective of release of security.
15.	For the supply items the Goods bearing the ISI mark or the approved make or specified by M.C. will be the min. standard and F.O.R. at Municipal Corporation, Bathinda.
16.	The comparative statement shall be as per the quoted rates.
17.	No condition regarding Validity Period and Time Limit is accepted.
18.	The contractor must have VAT Registration Number issued by Department of Excise and Taxation for the works more than 5 Lacs.
19.	All running payments shall be considered as advance payments to the contractors and any excess payment in running bills shall be recovered from the contractor's next or final bill.
20.	If any other type of tax (existing or imposed by the Govt.) the same will be borne by the agency.
21.	The unbalanced tender and tender against the instruction tender shall be rejected.
22.	The bidders should have EPF code number, He shall submit the copy of the same along with EMD with tender document; otherwise his tender will not be entertained.
23.	NIT, Terms and conditions and specifications can be seen in the office of Municipal Corporation on any working day.
24.	Analysis of NS item and for any other quarry contractor can contact the undersigned office on any working day.
25.	Tenders relating to Electric work will be issued to the contractors having valid license from Chief Electrical Inspector, Patiala.
