- 3. Processing fee will only be accepted through Net Banking (Direct Debit) and IPG (Credit/Debit card).
- 4. All the payments (EMD and Tender form cost) can be made either online or by submitting original DAC alongwith tender fee of Rs. 200/- each tender in the office of Corporation Engineer, Municipal Corporation, Bathinda, 2nd floor, in an Envelope marked Earnest Money, Tender fee and other necessary documents for the work of (Name of Work) on or before 2.30 PM on 25-10-2016 failing which the tender will be rejected.
- 5. Bidders/Contractors/tenderes can access for tender documents on the website mentioned above, fill them and submit the complete tender document into Electronic Tender on the website. Bidders/Contractors shall attach scanned copies of all the papers, i.e. Earnest Money, Processing Fee, Tender cost fee and certificates as required in terms and conditions.
- 6. Corrigendum/Addendum/Corrections, if any will be posted on the website only.
- 7. Agency should also upload the scanned copy of document such as PAN No, VAT No., EPF Code, Enlistment record, HMP-Ownership etc as required.

- 12. The L&C Co-Operative Societies shall submit its capacity certificate from the concerned authority of Co-Operative department along with tender.

- 13. The contractor shall not remove any installed material from site of work without prior approval of CMC Bathinda
- 14. All legal proceeding in connection with the contract shall be subject to the territorial jurisdiction of the civil courts at Bathinda only.
- 15. The contractor must have got EPF code no. prior to opening of tenders.
- 16. The bidder shall submit an undertaking that he would deposit EPF every month and if EPF department finds any recoverable amount from the bidder then the bidder would be bound to pay the same with interest or any penalty levied by EPF department.
- 17. The bidder shall also supply one identity proof.
- 18. The rates will be paid as per CSR 2010 and current premium applicable and amendment issued by Govt. from time to time.
- 19. Only BIS approved ISI marked paver blocks / interlocking tiles shall be used. The agency shall be produce bill of purchase tile from ISI license of the manufacturer at the time of receipt of material at site.
- 20. 	Newspaper/website will be given.
3	Sales Tax Number is must for participation in tendering.
4	Cost of the tender form is Rs. 200/- which is payable in the form of DD in favour
	of Municipal Corporation Bathinda, payable at Bathinda.
5	Free of Cost items, if quoted, shall be adjusted first or proportionally in
	payments as desired by the Engineer Incharge.
6	Sales Tax, Income Tax and other levies will be deducted from the contractor's
