1. Interested bidders can purchase the tender documents online from website.etender.punjabgovt.gov.in.
2. Processing fee will only be accepted through Net Banking (Direct Debit) and IPG (Credit/Debit card).
3. All the payments (EMD and Tender form cost) can be made either online or by submitting original DAC alongwith tender fee of Rs. 200/- each tender in the office of Corporation Engineer, Municipal Corporation, Bathinda, 2nd floor, in an Envelope marked Earnest Money, Tender fee and other necessary documents for the work of (Name of Work) on or **before 2.30 PM on 16/8/2016** failing which the tender will be rejected.
4. Bidders/Contractors/tenderes can access for tender documents on the website mentioned above, fill them and submit the complete tender document into Electronic Tender on the website. Bidders/Contractors shall attach scanned copies of all the papers, i.e. Earnest Money, Processing Fee, Tender cost fee, PAN No., VAT No. and certificates as required in terms and conditions.
5. Corrigendum/Addendum/Corrections, if any will be posted on the website only.

6. NIT and Terms and conditions have been/uploaded at website (etender.punjabgovt.gov.in), agencies should note that online tenders should only be submitted at the aforesaid website etender.punjabgovt.gov.in as per the details/instructions uploaded therein.
7. NIT, Terms and conditions and specifications are appended as Annexure A.
8. All legal proceeding in connection with the contract shall be subject to the territorial jurisdiction of the civil courts at Bathinda only.
9. Bidder shall give undertaking about no litigation and no blacklisting any Govt. department.
10. Any deviations from standard specifications shall have to be altered by bidder at his own risk and cost.
11. The Tender validity period is 120 days from the date of technical bid opening.
12. The total procurement period (i.e. Delivery Period) is 30 days.
13. Delivery location Municipal Corporation Stores at Bathinda.
14. 100% payment after 30 days from date of commissioning.
15. The Security Deposit will be paid back by after the satisfactory expiry of warranty period without any interest.
16. The Supplier is responsible for transit and all other insurances till the tools/ machineries /vehicles and equipment are commissioned at the location mentioned in the Procurement Order.
17. Taxes and duties shall be included in the indicated price. Tenderer has to quote the total price, net including of all taxes & duties etc. and for evaluation and finalisation purpose, the total price will be taken in to consideration. Transportation, Packing, Forwarding, Insurance charges are included in the indicated price.
18. Supplier shall warrant that the supply shall be warranted against faulty materials and workmanship for **"Tricycle with 8 Nos. plastic Container "** for a period of 12 months from the date of commissioning.
19. The bidder will arrange inspection of the **"Tricycle with 8 Nos. plastic Container"** by Municipal Corporation, Bathinda officials &/or Third Party (if required) along with Municipal Corporation, Bathinda officials, before delivery at factory/depot site. Inspection and commissioning of the **"Tricycle with 8 Nos. plastic Container"** will also be carried out at site specified by Municipal Corporation, Bathinda (if required). If any discrepancy is found in the material supplied and technical specifications approved, the same lot shall be rejected and bidder will collect rejected material within seven days.
20. No claim for the rejected material shall be entertained.
21. Liquidated damages for delay

Supplier in accordance with the schedule specified in the tender shall make delivery of the equipments. An unexcused delay by the supplier in the supply of its delivery obligations, supplier will be hold liable and Municipal Corporation, Bathinda can take actions to forfeit of his

bid security, imposition of liquidated damages and/or termination of the contract by default. If the supplier fails to deliver any or all of the equipments within the said period, Municipal Corporation, Bathinda shall deduct from the contract price as liquidated damages, a sum equivalent to 2 percent of the delivery price of the delayed goods per week or part thereof on the value of the delayed work will be recovered from the supplier without any reference to the supplier. The amount of Liquidated damages will be however subject to the maximum of 10% of the total contract sum. However, Delay in excess of one hundred (30) days after completion of delivery period may be cause for termination of contract and forfeiture of all security.
