General Terms and Conditions for Tenders

- 1. Interested bidders can purchase the tender documents online from website.eproc.punjab.gov.in.
- 2. Earnest money shall be paid in online mode only.
- Processing fee will only be accepted through Net Banking (Direct Debit) and IPG (Credit/Debit card).
- 4. All the payments (EMD & Tender form cost) and related document will be accepted online only.
- 5. Bidders/Contractors/tenderers can access tender documents on the website mentioned above, fill them and submit the complete tender document into electronically on the website.

 Bidders/Contractors shall attach scanned copies of all the documents, i.e. Earnest Money, Processing Fee, Tender cost fee and certificates/documents as required in terms and conditions.
- 6. Corrigendum/Addendum/Corrections, if any will be posted on the website only.
- 7. NIT and Terms and conditions have been/uploaded on website (eproc.punjab.gov.in.), agencies should note that online tenders should only be submitted at the aforesaid website eproc.punjab.gov.in as per the details/instructions uploaded therein.

- 11. The rates will be paid as per CSR 2020 and current premium applicable and amendment issued by Govt. from time to time.

- 12. Agency should compulsory upload the scanned copy of document such as PAN No, GST No., EPF No., ESIC No., Valid Enlistment Certificate, Self Declaration that the contractor /L&C Societies / Firms has not been blacklisted till the publication of tender notice, Identity proof, Capacity Certificate, Should be submitted in Technical Bid. In case of absence of any of the above document, the bidder shall lose eligibility.
- 13. Bidders whosoever are associated with the manufacturer/business of horticulture machinery can participate in the tendering process.
- The average annual turnover in the last five years should not be less than 50 lacs.
- 15. The bidder should have the ISO/ARAI certification.
- The bidder would be bound to supply the horticulture machinery of mentioned make and model.
- 17. The bidder should have experienced manpower for fabrication.
- 18. The maintenance period of the machine would be one year from the date of handing over the machine to MCB. The bidder would be responsible for the maintenance of horticulture machinery free of cost except accident during maintenance period. All electrical parts should be covered with the warranty of three months.
- 19. The successful tenderer shall warrant that material to be supplied shall be free from all defects and faults, workmanship and manufacture and shall be of the highest grade and consistent with the established and generally accepted standards for materials and in full conformity with the tender specifications and drawings or samples, if any, and shall operate properly and satisfactorily. The successful tenderer shall replace or repair the goods or such portion in case of defects or poor workmanship or any malfunction of the unit or any portion thereof.
- Successful firm shall have to provide the guarantee/warranty certificate before the release of balance 10% payment.
- The Contractor/Firms must have got EPF code no. and ESIC prior to opening of tenders (As applicable).

22. Bid Capacity:

The bid capacity of the prospective bidders will be calculated as under:

Assessed Available Bid Capacity = (A* N* 2 - B)

Where

A = Maximum value of Civil Engineering works executed in any one year (year means Financial year) during the last five years (updated to the price level of the Financial year in which bids are received at a rate per year as indicated in the BDS) taking into account the completed as well as works in progress.

N = Number of years prescribed for completion of the Project/Works for which these bids are being invited. (e.g. 7 months = 7/12 year)

B = Value (updated to the price level of the year indicated in B D S) of existing commitments (only allotted works) on the last date of submission of bids as per bidding document and on-going works to be completed during the period of completion of the Project/Works for which these bids are being invited.

Note: The statement showing the value of existing commitments and on-going works as well as the stipulated period of completion remaining for each of the works listed should be attached along with certificates duly signed by the Engineer-in Charge, not below the rank of an Executive Engineer or equivalent. The contractor/Society also have to submit self-attested undertaking that the Society/Contractor is eligible to take part in the tender and has available bid capacity on the basis of above formula.

4	Tax and other levies will be deducted from the contractor's bill as per rules.
5	DNIT and MW-4 shall be the part of the agreement.
6	Any or all tenders can be rejected by the competent Authority without assigning any reason.
7	Substandard materials will be rejected and shall not be payable.
8	For the supply items the goods bearing the ISI mark or the approved make or specified by M.C.
